## **Auditor's Report:**

Eric Van Dop from Brickley DeLong, CPA was present to discuss the 2022 Audit. The audit went well. General Fund Balance was at \$588,477 increased from last year's by \$70,279. Water Fund is at \$517,247 with a \$88,362 increase from last year and Sewer Fund is at \$996,105 with a \$19,796 increase from last year. The Water and Sewer Funds totals are both heading in the right direction. Single audit was in compliance.

Sandra Rollenhagen commented on a Zoning Board of Appeals issue.

**Business Office Report:** Clerk Carrigan has reported she has been working on final reports from the audit. She has also been working on public notices for zoning matters. Items have been added to the website with some corrections. She presented a quote from CCS Technologies regarding upgrading the cyber security at the Village Office. The clerk will search for other options.

**DPW Report**: DPW Supervisor Nelson reported many water and sewer hookups and irrigation. Heights Ravenna resurfacing is projected to start July 10<sup>th</sup>. The DPW will be doing another water and sewer hookup during the resurfacing project.

**Adoption of Ordinance & Resolutions: Dodson** moved **Plescher** supported to table Ordinance No. 158 An Ordinance to Amend the Zoning Ordinance of the Village of Ravenna [Site Development Standards]. Motion Carried 3/0.
