Jon will forward our ideas to Eric to follow-up with Mark, the village lawyer, to write up what a potential Chicken Ordinance would look like for the Village of Ravenna and for the planning commission to review.*

Old Business:

Hometown Pharmacy: does the Village Council wish to take any further action at this time? If so, how can Planning Council help?

Eric has been working on the issue/s with Hometown Pharmacy for the last 5 years between him & Brett Beecham/Hometown Pharmacy. Regarding the empty lot being presentable, etc. **Follow-up:** *Hometown Pharmacy plans to grade the lot and plant grass seed to make it a green space (with seating and/or landscaping) however, this may not be done by the fall, but, maybe by the springtime.* **Update:** Hometown Pharmacy is still planning on turning their lot into a green space, but, there's been discussion from the village board to make that area into a Splash Pad Area.
