Additional driveway lighting: not at this time (only in the parking lot area). Fence: front setback 8ft max height, starting 35" from centerline of street to the back of the property line. Concern on biggest traffic nights: Sunday mornings and Wednesday Nights: Home owners want fence not more trees. West side of road currently has trees, good buffer currently. Timing-est. target early Sept for completion, estimated 2-4 weeks to complete depending on sub-contractors availability. Postponed additional Pole Barn for bus garage, additional permit needed at later date.
